### **Team Coordinator (Consultant)**

The Clinical Supervisor Mental Health Therapist-Licensed serves as a member of the clinical team for one of the PSI outpatient mental health programs. The Clinical Supervisor is responsible for monitoring the welfare of the clients assigned to the team, ensuring compliance with professional standards of services, monitoring clinical performance and professional development of team members and evaluating team members performance of service delivery. Clinical Supervisor will conduct initial and annual diagnostic assessments, functional assessments to determine diagnosis and treatment recommendations. Writes individual treatment plans, behavior support plans and individual recovery plans for children and adults admitted for outpatient services. Conducts individual, group or family psychotherapy and completes all required documentation in each case and participates in case conference and special reviews. Must have a Master's Degree or Ph.D. in Psychology or Psychiatric Social work. Must be licensed as a Mental Health Counselor, Marriage and Family Counselor, Psychologist or Licensed Clinical Social Worker in Washington, DC with a minimum of three years of direct psycho-therapeutic work with adults or children with psychiatric disorders in the MHRS System and a year of supervisory experience. Certified Addiction Counselor for Substance Abuse is also preferred.

### **Therapist (Consultant)**

The Mental Health Therapist-Licensed serves as a member of the clinical team for one of the PSI outpatient mental health programs. The Therapist will conduct initial and annual diagnostic assessments, functional assessments to determine diagnosis and treatment recommendations. Writes individual treatment plans, behavior support plans and individual recovery plans for children and adults admitted for outpatient services. Conducts individual, group or family psychotherapy and completes all required documentation in each case and participates in case conference and special reviews.
